ORDINANCE NO.11-12-12

An ordinance of the Village of Brownville, Nebraska, providing extended hours for the onpremises sale of liquor; repealing all conflicting ordinances; and providing an effective date.

Be it ordained by the Chairman and Village Board of the Village of Brownville, Nebraska, as follows:

Section 1. That Section 10-117 of the municipal code be and hereby is amended to provide for the on-premises sale of liquor until the hour of 2:00 A.M. and shall read as follows:

10-117 ALCOHOLIC BEVERAGES: HOURS OF SALE. (1) It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the Municipality except during the hours provided herein:

HOURS OF SALE

Alcoholic Liquors (except Beer and Wine)

Monday through Saturday

Off Sale 6:00 a.m. to 1:00 a.m.

On Sale 6:00 a.m. to 2:00 a.m.

Sunday

Off Sale 12:00 p.m. to 1:00 a.m.

On Sale 12:00 p.m. to 2:00 a.m.

Beer and Wine

Daily

Off Sale 6:00 a.m. to 1:00 a.m.

On Sale 6:00 a.m. to 2:00 a.m.

- (2) Such limitations shall not apply after 12:00 noon on Sunday to a licensee which is a nonprofit corporation and the holder of a Class C or Class I license.
- (3) For the purposes of this section, "on sale" shall be defined as alcoholic beverages sold at retail by the drink for consumption on the premises of the licensed establishment. "Off sale" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.
- (4) It shall be unlawful on property licensed to sell alcoholic liquor at retail to allow alcoholic liquor in open containers to remain or be in possession or control of any person for purposes of consumption between fifteen minutes after the closing hour applicable to the licensed premises and 6 a.m. on any day.
- (5) Nothing in this section shall be construed to prohibit licensed premises from being open for business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this section.

SECTION 2: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3: This ordinance shall become effective from and after its passage, approval and publication as required by Nebraska law.
