- **♣** LOCAL TRAINING ORDNANCES:
 - THE CITY OF LINCOLN HAS ITS OWN ALCOHOL TRAINING AND ALCOHOL SERVER/SELLER PERMIT PROGRAM AND REQUIRES TRAINING FOR MANAGERS; SEE FBST/RBST & RHC WEBSITES
 - THE CITY OF KEARNEY REQUIRES SERVERS/SELLERS TO COMPLETE ONE OF THE TRAINING PROGRAMS FROM THE ATTACHED LIST;
 - ➤ NEBRASKA CITY/OTOE COUNTY AND THE CITIES OF OGALLALA AND NORTH PLATTE HAVE LOCAL TRAINING REQUIREMENTS. CHECK WITH THE CLERK'S OFFICE FOR DETAILS;
