ORDINANCE NO.847

AN ORDINANCE OF THE CITY OF HOOPER, NEBRASKA, TO AMEND SECTION 10-112 OF THE MUNICIPAL CODE OF THE CITY OF HOOPER, NEBRASKA, BY CHANGING THE HOURS OF SALE OF ALCOHOLIC LIQUOR, INCLUDING BEER, WITHIN THE CITY OF HOOPER, NEBRASKA, TO PROVIDE FOR THE SEVERABILITY OF ANY SECTION, CLAUSE, PROVISION OR PORTION FOUND UNCONSTITUTIONAL OR INVALID; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HOOPER, NEBRASKA, AS FOLLOWS:

SECTION 1. That portion of Section 10-112 of the Municipal Code of the City of Hooper, Nebraska pertaining to "HOURS OF SALE", be amended to permit the "ON AND OFF SALES" of Alcoholic Liquors as follows:

Provided that such limitations shall not apply after twelve o'clock (12:00) Noon on Sunday to a licensee which is a nonprofit corporation holding a license pursuant to section 53-124(5) (C) & (H) Reissue Revised Statues of Nebraska 1943. No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than fifteen (15) minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises.

Nothing in this section shall be construed to prohibit licensed premises from being open for business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this section.

SECTION 2. That if any section, clause, provision or portion of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

SECTION 3. That all ordinances or parts of ordinances passed and approved prior to the passage, approval and publication of this Ordinance, in conflict herewith, are hereby repealed

SECTION 4. That this Ordinance shall be in full force and effect after its passage, approval and publication according to law.
