Renewal Publication Reminder - Class "C" Licenses

Retail licenses renewal; notice.

The city, village, or county clerk shall cause to be published in a legal newspaper in or of general circulation in such city, village, or county, one time between January 10 and January 30 of each year, individual notice of the right of automatic renewal of each retail liquor and beer license, except that notice of the right of automatic renewal of Class C licenses shall be published between the dates of July 10 and July 30 of each year within such city, village, or county, in substantially the following form:

Notice is hereby given pursuant to section <u>53-135.01</u> that a liquor license may be automatically renewed for one year from May 1, 20...., or **November 1, 20....**, for the following retail liquor licensee:

§53-135.01.

Retail licenses; bottle club licenses; renewal; notice.

The city, village, or county clerk shall cause to be published in a legal newspaper in or of general circulation in such city, village, or county, one time between January 10 and January 30 of each year, individual notice of the right of automatic renewal of each retail liquor and beer license and each bottle club license, except that notice of the right of automatic renewal of Class C licenses shall be published between the dates of July 10 and July 30 of each year within such city, village, or county, in substantially the following form:

NOTICE OF RENEWAL OF RETAIL LIQUOR OR BOTTLE CLUB LICENSE

Notice is hereby given pursuant to section <u>53-135.01</u> that a liquor license [or bottle club license] may be automatically renewed for one year from May 1, 20...., or November 1, 20...., for the following retail liquor [or bottle club] licensee:

Notice is hereby given that written protests to the issuance of automatic renewal of license may be filed by any resident of the city (village or county) on or before February 10, 20...., or August 10, 20...., in the office of the city (village or county) clerk and that in the event protests are filed by three or more such persons, hearing will be had to determine whether continuation of the license should be allowed.

All license fees received by the City/Village or County Treasurer shall be credited to the school fund of the District or the County per §53-138.01. The City/Village or the County Clerk may collect occupation taxes as provided for by local ordinance in an amount not to exceed double the amount of the annual license. The license fee and occupational tax shall be prorated on a quarterly basis from the date of issuance.

Special Designated License Reminders:

Late SDL applications will be rejected. There are no exceptions or refunds.

013.04 Applications for Special Designated Liquor Licenses by non-licensees request ing a waiver or modification of conditions along with the reasons and justification for such waiver or modification must be received by the Liquor Control Commission at least 30 calendar days prior to the licensed event. When no waiver or modification is required the Commission must receive Special Designated Liquor License applications at least 10 working days prior to the licensed event.

Only (12) Special Designated licenses are allowed in one location per calendar year. There are currently locations that are exempt from this rule that have been approved by the Commission.

013.06 It is the declared policy of the Commission that Special Designated Licenses should not be used to avoid the oversight and accountability imposed upon a regular retail license. Therefore, applications for Special Designated Licenses may be denied if the proposed location could otherwise be granted a regular license and if such regular license best serves the purposes of the Liquor Control Act. To help accomplish this policy any location that has received twelve (12) Special Designated Licenses in one calendar year shall have any further applications set for hearing to make a deterdetermination whether additional licenses are justified prior to the issuance of the requested Special Designated License.

- ♦ Retail licensees with catering (K) endorsement will still need to apply for a Special Designated License each time they go off their licensed premise to serve alcohol.
- Licensed areas need to be connected in order for one application to be filed. Non-connected areas require a separate application.
- ♦ Non-consecutive dates require a separate Form #200.
- ♦ End time of event should only be listed as one date even though it is technically a different date, since it is after midnight.
- ♦ Both the City and County name should not be written at the bottom of Form #200. Only the <u>one</u> name that pertains to your jurisdiction.
- All blanks and signatures should be completed on Form #200. For example: <u>See attached diagram</u> is not sufficient.
- Only current SDL forms found on our website will be accepted. Please do not use old copies of forms.

Active License Roster – An active license roster can be purchased by anyone at any time for their specific use, for example a research project or advertisement of a company's product they would like to promote. The most common format that is used for the information is an Excel spreadsheet but labels and hardcopy can be requested. The information requested could be for all license holders in a specific county, a specific class of license in the state or a city, etc.

Keg Books – Keg books are ordered by off sale license holders that sell kegs for consumption. There are 25 pages in a keg book with each page having a specific dedicated number which coincides with the keg sticker itself. The retailer completes the Keg Registration Declaration page and adheres the keg sticker on the keg that has been sold. The purchaser is required to sign this declaration. The NLCC tracks which books/numbers have been purchased by a retailer so in the case of NSP inquiring we are able to match up where they came from.

Law Books – The last printing of NLCC lawbooks was in 2013. Currently there are no plans on a new printing in the near future. All clerks and the public are being directed to see the most current statutes and rules and regulations on the NLCC website from the "Legal" tab select Statutes or Rules and Regulations
