ORDINANCE NO. 3577

AN ORDINANCE TO AMEND SECTION 4-12 OF THE BELLEVUE MUNICIPAL CODE PERTAINING TO HOURS OF SALE OF ALCOHOLIC BEVERAGES IN THE CITY OF BELLEVUE; TO REPEAL SUCH SECTION AS HERETOFORE EXISTING; AND TO PROVIDE FOR THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF BELLEVUE, NEBRASKA.

Section 1. That Section 4-12 of the Bellevue Municipal Code is hereby amended to read as follows:

Sec. 4-12. Alcoholic beverages; hours of sale.


- (a) For the purposes of this section, "on the premises" shall be defined as alcoholic beverages sold at retail by the drink for consumption on the premises of the licensed establishment. "Off the premises" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.
- (b) It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the City of Bellevue during the hours provided herein:
- i. The sale or distribution for consumption off the premises on any day between the hours of 1:00 a.m. and 6:00 a.m.; or
 - ii. The sale or dispensing for consumption on the premises on any day between the hours of 2:00 a.m. and 6:00 a.m.; or
 - iii. On any Sunday the sale or dispensing of alcoholic liquor, other than beer and wine, for consumption on the premises or off the premises, shall be prohibited between the hours of 6:00 a.m. and 12:00 noon.
- Provided that such limitations shall not apply after 12:00 noon on Sunday to a licensee which is a nonprofit corporation holding a license pursuant to section 53-124(5)(c) and (e), Reissue Revised Statutes of Nebraska 1943.
- (c) No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than 15 minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises.
- (d) Nothing in this section shall be construed to prohibit licensed premises from being open for other business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this section.


Section 2. That Section 4-12 of the Bellevue Municipal Code as heretofore existing is hereby repealed in its entirety.

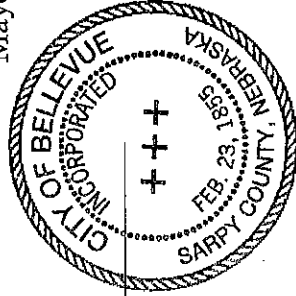
Section 3. This Ordinance shall take effect and be in full force on the latter of July 15, 2010, or from and after its passage, approval and publication as provided by law.
