ORDINANCE NO. 420

AN ORDINANCE TO RELATING TO ALCOHOLIC BEVERAGE; TO REVISE THE PROVISIONS RELATING TO HOURS OF SALE; TO HARMONIZE WITH STATE LAW; TO REPEAL CONFLICTING ORDINANCES AND SECTIONS; AND TO PROVIDE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRMAN AND THE BOARD OF TRUSTEES OF THE VILLAGE OF POTTER, NEBRASKA.

<u>Section 1.</u> That §111.05 ALCOHOLIC BEVERAGES; HOURS OF SALE of the Municipal Code of the Village of Potter, Nebraska, is amended to read as follows:

- A. It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the village on any day between the hours of 2:00 a.m. and 6:00 a.m. except that the Village Board with respect to area inside the corporate limits of the municipality may by ordinance require closing prior to 2:00 a.m. on any day if adopted by a vote of at least two-thirds of the members of the Village Board.
- B. It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic liquor, including beer within the corporate limits of the Village except during the hours provided herein:

- C. It shall be unlawful on property licensed to sell alcoholic liquor at retail to allow alcoholic liquor in open containers to remain or be in possession or control of any person for purposes of consumption between the hours of 15 minutes after the closing hour applicable to the licensed premises and 6:00 a.m. on any day.
- Nothing in this section shall prohibit licensed premises from being open for other business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this section.

<u>Section 2:</u> That any other ordinance or passed and approved prior to the passage, approval and publication of this Ordinance and in conflict with the provisions of this Ordinance, is hereby repealed.

<u>Section 3:</u> This Ordinance shall go into full force and effect upon its passage, approval and publication or posting as required by law.
