ORDINANCE NO. 10-008

AN ORDINANCE OF THE VILLAGE OF SNYDER, NEBRASKA, AMENDING SECTION 4-205 IN REGARD TO THE HOURS OF SALE OF ALCOHOLIC LIQUORS WITHIN THE VILLAGE; REPEALING CONFLICTING ORDINANCES OR PARTS OF ORDINANCES; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRMAN AND VILLAGE BOARD OF THE VILLAGE OF SNYDER, NEBRASKA AS FOLLOWS:

SECTION 1: That Section 4-205 of the revised municipal code be and hereby is amended to read as follows:

SECTION 4-205: HOURS OF SALE

For the purposes of this section, "on-sale" shall be defined as alcoholic beverages sold by the drink for consumption on the premises of the licensed establishment; "off-sale" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

It shall be unlawful for any person or persons or their agents to sell at retail or dispense any alcoholic beverages within the Village except during the hours specifically provided herein:

Alcoholic Liquors (except Beer and Wine)

Monday through Saturday

6:00 A.M. to 1:00 A.M. the following day Off Sale

On Sale 6:00 A.M. to 2:00 A.M. the following day

Sunday

12:00 P.M. to 1:00 A.M.the following day Off Sale

6:00 A.M. to 2:00 A.M. the following day On Sale

Beer and Wine

Monday through Saturday

6:00 A.M. to 1:00 A.M. the following day Off Sale

6:00 A.M. to 2:00 A.M. the following day On Sale

Sunday

6:00 A.M. to 1:00 A.M. the following day Off Sale On Sale 6:00 A.M. to 2:00 A.M. the following day

No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than 15 minutes after the time fixed herein for the stopping of sales of alcoholic beverages on said premises.

Nothing in this section shall be construed to prohibit licensed premises from being open for other business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this section.

SECTION 2: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3: This ordinance shall be effective from and after its passage, approval and publication as required by law.
