This is a Change Request for \$27,750 which is 150 hours. Our agency would draw down from this bucket of hours for application support work. Any hours used would be billed in detail and paid on a monthly basis. Through June 30, 2025, we have been billed monthly without a CR in place. Starting 7/1/25, CR008 will be used, which aligns with State Accounting practices because we can include it with NLCC/CX contract. For 6 months, we have been using an average of 46 hours per month of support work. The last month has lowered to 15 hours. It is anticipated repeating this CR every 6 months to accommodate the support required for our online systems.
