## HOW TO - CERTIFIED ALCOHOL SERVER/SELLER TRAINING IN POSSE

This page goes over how to get you and your staff certified alcohol server/seller training certificates in POSSE. These certificates can be to comply with a commission mandated order or for educational purposes for you and your staff.

### FOR THOSE COMPLYING WITH A COMMISSION ORDER PLEASE COMPLETE THIS STEP FIRST

If you are a business owner completing training to comply with a commission order you must first email <a href="mailto:lcc.training@nebraska.gov">lcc.training@nebraska.gov</a> a list of all of your employees who serve/sell alcohol as well as any in state owners. Please include your business name and your liquor license number in the subject of the email. Your employee list must include:

- First name
- Last name
- Date of birth
- Valid email address

A staff member will take this list and create an employee roster that can be viewed in your customer portal. This is a mandatory step in order to comply with the commission order.

#### Step 1: Create a customer portal account

ABC (nebraska.gov) Click this link to be taken to the POSSE customer portal login.

This step is required for anyone trying to get a certified alcohol server/seller training certificate including those getting certificates in order to comply with commission order. You must have a valid email address to create a customer portal account.

#### Step 2: Complete a training course from our certified alcohol training courses list.

Before you can become certified with the NLCC you must complete a training course off of our certified alcohol training courses list. At the end of every course, you will have the ability to print or download a training certificate. This training certificate should include your first and last name and an expiration date. All training certificates in the state of Nebraska expire after three years. Once you receive your certificate please make sure to save it for your records.

#### Step 3: Apply for Server/Seller certification in customer portal

After you have successfully completed a course from the Certified Alcohol Training Courses list you are ready to get your training certified through the NLCC. Go to your customer portal and click the getting started button at the top of your screen. Scroll down to the Certification and Education tab. From there you will be able to apply for a Server/Seller certification.

In order to receive your certified alcohol Server/Seller certification you must complete and submit these three things

- 1. Upload your training certificate you received from the training course you completed earlier.
- 2. Get a 100% on the NLCC guiz. You have unlimited attempts at this guiz.
- 3. Pay the \$15 processing fee.
