§ 112.13 ORIGINAL PACKAGE.

It shall be unlawful for any person or persons who own, manage, or lease any premises in which the sale of alcoholic beverages is licensed, to have in their possession for sale at retail any alcoholic liquors contained in casks or other containers except in the original package. Nothing in this section shall prohibit the refilling of original packages of alcoholic liquor for strictly private use and not for resale. (Neb. § 112.14 MINOR'S PRESENCE.

It shall be unlawful for any person or persons who own, manage, or lease an establishment selling alcoholic beverages at retail to allow any minor under the age of 18 years to frequent or otherwise remain in the said establishment unless the said minor is accompanied by his or her parent or legal guardian, and unless said minor remains seated with, and under the immediate control of, the said parent or legal guardian.

§ 112.15 HOURS OF SALE.

(A) For the purposes of this section **ON SALE** shall be defined as alcoholic beverages sold at retail by the drink for consumption on the premises of the licensed establishment. **OFF SALE** shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

(B) It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the municipality except during the hours provided herein.

(C) Hours of sale.

(1) *Alcoholic liquors (except beer and wine).*

(a) *Secular days.*

1. Off sale: 6:00 a.m. to 1:00 a.m. of the following day.
2. On sale: 6:00 a.m. to 1:00 a.m. of the following day.

1. Off sale: 6:00 a.m. to 1:00 a.m. Monday.
2. On sale: 6:00 a.m. to 1:00 a.m. Monday.

(2) *Beer and wine.***(a) *Secular days.***

1. Off sale: 6:00 a.m. to 1:00 a.m. of the following day.
2. On sale: 6:00 a.m. to 1:00 a.m. of the following day.

(b) *Sundays.*

1. Off sale: 6:00 a.m. to 1:00 a.m. Monday.
2. On sale: 6:00 a.m. to 1:00 a.m. Monday.

(3) *Time period.* No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than fifteen minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises.

§ 112.16 SANITARY CONDITIONS.

It shall be unlawful to open for public use any retail liquor establishment that is not in a clean and sanitary condition. Toilet facilities shall be adequate and convenient for customers and patrons and said licensed premises shall be subject to any health inspections the governing body or the municipal police may make or cause to be made. All applications for liquor licenses shall be viewed in part from the standpoint of the sanitary conditions, and a report concerning the said sanitary conditions shall be made at all hearings concerning the application for, or renewal of, a liquor license.

§ 112.17 HIRING MINORS.

It shall be unlawful for any person to hire a minor regardless of sex under the age of 19 years to serve or dispense alcoholic liquors, including beer, to said licensee's customers.
