ORDINANCE NO. 2016-O-006

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE CITY OF RAVENNA, NEBRASKA, UNDER TITLE XI ENTITLED "BUSINESS REGULATIONS"; CHAPTER 111 ENTITLED "ALCOHOLIC BEVERAGES"; SECTION 111.53 ENTITLED "HOURS OF SALE"; TO PROVIDE FOR A CHANGE TO THE HOURS WHEN ALCOHOLIC LIQUORS AND BEVERAGES MAY BE SOLD WITHIN THE MUNICIPALITY; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith AND PROVIDING WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT AND ORDERING THE PUBLICATION OF SAID ORDINANCE AS PROVIDED BY LAW.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF RAVENNA, NEBRASKA.

Section 1. An ordinance to amend the Municipal Code of the City of Ravenna, Title XI "Business Regulations", Chapter 111 "Alcoholic Beverages", Section 111.53 entitled "Hours of Sale"; to provide for a change to the hours when alcoholic liquors and beverages may be sold within the municipality, as follows:

Section 2. Section 111.53 is hereby amended to state as follows:

§111.53 HOURS OF SALE

(A) For the purpose of this section, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

OFF SALE. Alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

ON SALE. Alcoholic beverages sold at retail by the drink for consumption on the premises of the licensed establishment.

(B) It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the municipality except during the hours provided herein.

(C) No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than 15 minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises.

(D) Nothing in this section shall be construed to prohibit licensed premises from being open for business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this section.


Section 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. That this ordinance shall be published in pamphlet form and shall be in full force and take effect from and after its passage, approval and publication as provided by law.
