ORDER

Now on the 7th day of December 2021, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The licensee was present and represented by Attorney James Carson. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

A motion to Quash the citation was overruled by the hearing officer.  
The Licensee Plead Guilty to the citation after motion was overruled.

FINDING OF FACT:

- 1. That the licensee did, on or about July 1, 2021, permit the selling, of alcoholic liquor for consumption off the licensed premises while such person is in any manner within any motor vehicle.

CONCLUSION OF LAW:

- 1. That permitting the selling, of alcoholic liquor for consumption off the licensed premises while such person is in any manner within any motor vehicle is in violation of Neb. Rev. Stat. Sec. 53-178.01.
- 2. That the license should be suspended for a period of five (5) days, with the option to pay a fine in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class D Liquor License of TFL Inc, DBA – “Mega Saver”, 4108 Dodge Street, Omaha, Nebraska, should be, and the same hereby is, suspended for a period of five (5) days, such suspension to commence at the closing hour of business on the 20th day of February 2022, and to continue until the opening hour of business on the 26th day of February 2022, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$35.00.
