

**ORDINANCE NO. 524  
OF THE VILLAGE OF AXTELL, NEBRASKA**

**AN ORDINANCE OF THE VILLAGE OF AXTELL, NEBRASKA, AMENDING AXTELL MUNICIPAL CODE SECTION 110.48 REGARDING THE HOURS OF SALE OF ALCOHOLIC LIQUORS; REPEALING ALL PRIOR ORDINANCES AND RESOLUTIONS, OR PARTS THEREOF, IN CONFLICT HEREWITH; AND PROVIDING FOR THE EFFECTIVE DATE OF THIS ORDINANCE.**

**BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF AXTELL, NEBRASKA, AS FOLLOWS:**

1. That Section 110.48 of the Axtell Municipal Code is hereby amended so as to read and provide as follows:

**“Section 110.48 HOURS OF SALE.**

(A) No alcoholic liquors shall be sold at retail or dispensed inside the corporate limits of the village except during the following hours:

(B) For the purpose of this section, the following definitions shall apply unless the context clearly indicates or requires a different meaning:

**OFF SALE.** Alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

**ON SALE.** Alcoholic beverages sold at retail by the drink for consumption on the premises of the licensed establishment.

(C) It shall be unlawful on property licensed to sell alcoholic liquor at retail to allow alcoholic liquor in open containers to remain or be in possession or control of any person for the purposes of consumption between the hours of 15 minutes after the closing hour applicable to the licensed premises and 6:00 a.m. on any day.


(D) Nothing in this section shall prohibit licensed premises from being open for other business on days and hours during which the sale or dispensing of alcoholic liquor is prohibited by this section.

2. All prior ordinances and resolutions, or parts thereof, in conflict herewith, are hereby repealed.


3. This Ordinance shall be in full force and effect from and after its passage, approval, and publication according to law.
