ORDER

Now on the 7th day of May 2019, this matter came on for consideration before the Nebraska Liquor Control Commission, the licensee having executed a voluntary appearance, waiver of public hearing, plea of guilty, and consent to judgment, in regard to the charge filed on the 9th day of April 2019.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did purchase, receive, acquire, accept or possess alcoholic liquors from persons not authorized to sell to the licensee, in violation of Neb. Rev. Stat. Sec. 53-175.
2. That the licensee did, on or about January 18th, 2019, have in its possession, for sale at retail, refilled bottles of alcoholic liquor, which said bottles were not the original bottles for said alcoholic liquor, in violation of Neb. Rev. Stat. Sec. 53-184 and/or 237-LCC6-019.01J of the Rules and Regulations of the Nebraska Liquor Control Commission.
3. That the license should be suspended for ten (10) on charge #1 and suspended for ten (10) days on charge #2 for a total period of twenty (20) days, with the option to pay a fine in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class I Liquor License of Rusty Bartlett, DBA – “Beer N Bones BBQ Roadhouse”, 124 S 23rd Street, Beatrice, Nebraska, should be, and the same hereby is, suspended for ten (10) days on charge # 1 and suspended for ten (10) days on charge #2 for a total period of twenty (20) days, such suspension to commence at the closing hour of business on the 7th day of July 2019, and to continue until the opening hour of business on the 28th day of July 2019, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.


IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$0.00.
