ORDER

Now on the 9th day of August 2016, this matter came on for consideration before the Nebraska Liquor Control Commission, the licensee having executed a voluntary appearance, waiver of public hearing, plea of guilty, and consent to judgment, in regard to the charge filed on the 13th day of June 2016.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did, on or about January 21, 2016 purchase alcoholic liquor from Nebraskaland and did accept merchandising credit thereupon for a period exceeding thirty days, in violation of Neb. Rev. Stat. Sec. 53-168 and/or 237-LCC6-019.01K and 237-LCC6-018.01A of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. That the licensee did on or about January 21, 2016 purchase, receive, acquire, accept or possess alcoholic liquors from persons not authorized to sell to the licensee, in violation of Neb. Rev. Stat. Sec. 53-175.
3. That the license should be suspended for a period of five (5) days on charge #1 and suspended for five (5) days on charge #2 for a total period of ten (10) days, with the option to pay a fine in lieu thereof.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of Black, Daniel, DBA – “Blackshirt Liquor”, 300 Deweese Avenue, Deweese, Nebraska, should be, and the same hereby is, suspended for a period of five (5) days on charge #1 and suspended for five (5) days on charge #2 for a total period of ten (10) days suspension, such suspension to commence at the closing hour of business on the 25th day of September 2016, and to continue until the opening hour of business on the 6th day of October 2016, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$0.00.
