INSTRUCTIONS FOR SUBMITTING TRAINING DOCUMENTATION & FEE PAYMENTS

ALCOHOL SERVER/SELLER TRAINING:

- ✦ TRAINING IS NOT MANDATORY IN NEBRASKA AT THIS TIME. TRAINING FOR MANAGEMENT AND STAFF IS STRONGLY ENCOURAGED AS PART OF NEW HIRE TRAINING AND ONGOING STAFF EDUCATION. CERTIFICATION OF COMPLETING AN APPROVED TRAINING PROGRAM WITH OUR OFFICE IS VOLUNTARY, WITH THE FOLLOWING EXCEPTIONS:
- ✦ LOCAL TRAINING ORDINANCES:
 - THE CITY OF LINCOLN HAS ITS OWN ALCOHOL TRAINING AND ALCOHOL SERVER/SELLER PERMIT PROGRAM AND REQUIRES TRAINING FOR MANAGERS;
 - THE CITY OF KEARNEY REQUIRES SERVERS/SELLERS TO COMPLETE ONE OF THE TRAINING PROGRAMS FROM THE ATTACHED LIST;
 - NEBRASKA CITY/OTOE COUNTY AND THE CITIES OF OGALLALA AND NORTH PLATTE HAVE LOCAL TRAINING REQUIREMENTS. CHECK WITH THE CLERK'S OFFICE FOR DETAILS;
 - CHECK WITH YOUR LOCAL CITY AND COUNTY CLERK'S OFFICES FOR ANY TRAINING REQUIREMENT AND SPECIFICS OF ANY REQUIREMENT.
- ✦ THE NLCC MAY REQUIRE TRAINING AS PART OF THE LICENSING PROCESS AND MAY REQUEST THAT THE OWNER(S), PARTNERS OR CORPORATE OFFICERS/LLC MEMBERS & MANAGER ON THE APPLICATION COMPLETE ONE OF THE TRAINING PROGRAMS WHEN THERE IS INSUFFICIENT EXPERIENCE SELLING ALCOHOL IN NEBRASKA. ADDITIONALLY, IN THE EVENT OF A VIOLATION, ALL STAFF & MANAGEMENT MAY BE REQUIRED TO COMPLETE A TRAINING PROGRAM AS PART OF A COMMISSION ORDER.
- ✦ TO REGISTER YOUR TRAINING WITH OUR OFFICE, SUBMIT A COPY OF YOUR COURSE COMPLETION DOCUMENTATION RECEIVED FROM ANY OF THE TRAINING PROGRAMS ON THE ATTACHED LIST AND A \$10 PER PERSON PROCESSING FEE.

PAYMENT INSTRUCTIONS:

- ✦ DEBIT/CREDIT CARD PAYMENTS AND eCHECK (DIRECT DEBIT TO YOUR BANK ACCOUNT) PAYMENTS CAN BE MADE FROM OUR WEBSITE (www.lcc.nebraska.gov) USING THE PAYPORT LINK PROVIDED ON OUR HOME PAGE. THIS IS OUR PREFERRED METHOD OF PAYMENT TO BE USED WHENEVER POSSIBLE. FOR TRAINING PROCESSING FEES, SELECT "TRAINING CERTIFICATE" IN THE DROP DOWN MENU BOX FOR THE *TRANSACTION ITEM* FIELD.
- ✦ WE NO LONGER ACCEPT DEBIT/CREDIT CARD INFORMATION FOR PAYMENTS BY PHONE OR IN PERSON. ALL DEBIT/CREDIT CARD PAYMENTS MUST BE PROCESSED THROUGH PAYPORT. IF PAYING IN OUR OFFICE, ACCESS TO PAYPORT WILL BE PROVIDED.
- ✦ PAYMENTS BY CHECK OR MONEY ORDER (NOT PREFERRED) MAY BE MADE BY MAIL OR IN PERSON; CASH PAYMENTS IN THE EXACT AMOUNT WILL BE ACCEPTED IN PERSON ONLY.
