ORDER

Now on the 9th day of October 2018 and 4th day of December 2018, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The licensee was present and represented by Attorney Robert Bartle. The State was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds: FINDINGS OF FACT:

1. That the licensee did, on or about February 28th, 2018 and March 1st, 2018, by and through its authorized representative, provide false information to the Liquor Control Commission Investigators regarding the presence of alcohol in Casey's licensed locations.

CONCLUSION OF LAW:

1. That providing false information to the Liquor Control Commission Investigators regarding the presence of alcohol in Casey's licensed locations is in violation of 237 NAC 2-011.01.
2. That the license should be suspended for a period of fifteen (15) days, with the option to pay a fine in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class D Liquor License of Casey's Retail Company, DBA – "Casey's General Store 2968", 130 Highway 34, Eagle, Nebraska, should be, and the same hereby is, suspended for a period of fifteen (15) days, such suspension to commence at the closing hour of business on the 24th day of February 2019, and to continue until the opening hour of business on the 12th day of March 2019, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$0.00.
