AN ORDINANCE OF THE VILLAGE OF ELBA, HOWARD COUNTY, NEBRASKA AMENDING ORDINANCE NO. 117 OF THE VILLAGE OF ELBA, NEBRASKA; PROVIDING FOR HOURS OF SALE OF ALCOHOLIC BEVERAGES; REPEALING ALL ORDINANCES OR PARTS THEREOF IN CONFLICT WITH THIS ORDINANCE; AND PROVIDING FOR THE TIME THIS ORDINANCE SHALL BE IN FULL FORCE AND TAKE EFFECT.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF ELBA, NEBRASKA:

Section 1. Section 1 of Ordinance No. 117 of the Village of Elba, Nebraska, shall read as follows:

Section 1. ALCOHOLIC BEVERAGES; HOURS OF SALE. It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the Municipality except during the hours provided herein:

Off Sale6:00 A.M. to 1:00 A.M.
On Sale.6:00 A.M. to 1:00 A.M.
Bottle Club.6:00 A.M. to 1:00 A.M.

Sundays

Off Sale12:00 Noon to 1:00 A.M.
On Sale.12:00 Noon to 1:00 A.M.
Bottle Club.12:00 Noon to 1:00 A.M.

No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than fifteen (15) minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises. For the purposes of this Section, "on sale" shall be defined as alcoholic beverages sold by the drink for consumption on the premises of the licensed establishment; "off sale" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

Nothing in this section shall be construed to prohibit licensed premises from being open for other business on days and hours during which the sale or

dispensing of alcoholic beverages is prohibited by this ~~Section~~

Section 2. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

Section 3. This Ordinance shall be in full force and take effect from and after its passage, approval and publication, according to law.
