ORDER

Now on the 7<sup>th</sup> day of September 2022, this matter came on for consideration before the Nebraska Liquor Control Commission, upon a Motion to Reconsider filed by Shoup Inc., dba "Endzone Sports Grill", 8525 Park Drive, Omaha, Nebraska, said licensee having been previously cancelled by this Commission in Order dated August 15<sup>th</sup>, 2022.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the motion to reconsider shall be granted.
2. That the licensee did purchase, receive, accept, or possess alcoholic liquors from persons not authorized to sell to the licensee in violation of Neb. Rev. Stat. Sec. 53-175.
3. That the license should be suspended for a period of twenty-five (25) days, with the option to pay a fine in lieu thereof.
4. That the licensee shall pay excise tax in the amount of \$6.26 within thirty (30) days of this order.
5. That the alcohol seized during this investigation shall be destroyed by the Nebraska State Patrol in accordance with Neb. Rev. Stat. 53-1,113.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of Shoup Inc, DBA – "Endzone Sports Grill", 8525 Park Drive, Omaha, Nebraska, should be, and the same hereby is, suspended for a period of twenty-five (25) days, such suspension to commence at the closing hour of business on the 6th day of November 2022, and to continue until the opening hour of business on the 2nd day of December 2022, with the option to pay a fine in lieu thereof. Additionally, that the licensee shall pay excise tax in the amount of \$6.26 within thirty (30) days of this order. Furthermore, That the alcohol seized during this investigation shall be destroyed by the Nebraska State Patrol in accordance with Neb. Rev. Stat. 53-1,113.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$35.00.
