ORDER

Now on the 1st day of August 2023, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The Licensee was present. The Commission was represented by Ken Yoho, Assistant Attorney General. A plea of guilty was given upon opening.

FINDING OF FACT:

1. That the licensee did, on April 11, 2023, purchase alcoholic liquor from Southern Glazer's of Nebraska and did accept merchandising credit thereupon for a period exceeding thirty days.

CONCLUSION OF LAW:

2. That the licensee did, on April 11, 2023, purchase alcoholic liquor from Southern Glazer's of Nebraska and did accept merchandising credit thereupon for a period exceeding thirty days, in violation of Neb. Rev. Stat. Sec. 53-168 and/or 237-LCC6-019.01K and 237-LCC6-018.01A of the Rules and Regulations of the Nebraska Liquor Control Commission.
3. That the licensee should be suspended for a period of five (5) days, with the option to a penalty in lieu thereof.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class I Liquor License of Fedorchik, Todd A, DBA – "Fordors Billiards and Darts", 6111 4th Ave, Ste 4, Kearney, Nebraska, should be, and the same hereby is, suspended for a period of five (5) days, such suspension to commence at the closing hour of business on the 22nd day of September 2023, and to continue until the opening hour of business on the 28th day of September 2023, with the option to pay a penalty in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.


IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$113.95.
