

ORDINANCE 2412

AN ORDINANCE TO AMEND CHAPTER 10, ARTICLE 1, SECTION 10-117 OF THE HOLDREGE MUNICIPAL CODE RELATED TO ALCOHOLIC BEVERAGES; HOURS OF SALE: TO REPEAL ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR THE SEVERABILITY OF ALL PARTS HEREOF; AND TO DESIGNATE THE TIME DESCRIBED WHEN THIS ORDINANCE SHALL BE IN EFFECT.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HOLDREGE, NEBRASKA.

Section 1. Section 10-117 of the Holdrege Municipal Code is hereby amended to read:

§10-117 ALCOHOLIC BEVERAGES; HOURS OF SALE. It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverage within the Municipality except during the hours provided herein:

(A) No alcoholic beverages shall be sold at retail or dispensed on any day between the hours of 1:00 a.m. and 6:00 a.m.

(B) In addition to the restriction set forth in § 10-117(A), it shall be unlawful for any person or persons to sell at retail any alcoholic beverages during the hours that polling stations are open on the day in which any statewide primary or general election is conducted.

(C) No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than fifteen (15) minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises. For the purposes of this Section, "on sale" shall be defined as alcoholic beverages sold by the drink for consumption on the premises of the licensed establishment; "off sale" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.


(D) Nothing in this Section shall be construed to prohibit any licensed premise from being open for other business during hours which the sale or dispensing of alcoholic beverages is prohibited by this Section.


Section 2. If any section, subsection, paragraph, sentence, clause or phase of this ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this ordinance, which shall remain in full force and effect and to end the provisions of this ordinance are hereby declared to be severable.

Section 3. This ordinance shall be in full force and effect after its passage and publication as prescribed by law.

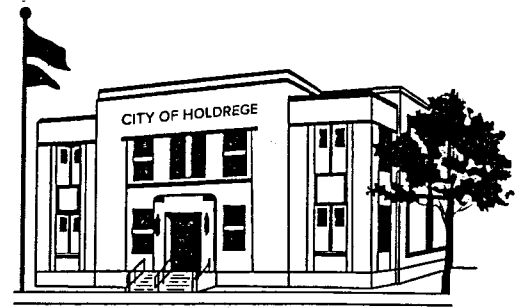
