ORDER

Now on the 6th day of August 2019, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The licensee was present and represented by Attorney Richard Boucher. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:
FINDINGS OF FACT:

- 1. That the licensee did, on or about March 1, 2019, permit the selling, dispensing or giving away of alcoholic liquor, to or for an individual being less than 21 years of age.

CONCLUSION OF LAW:

- 1. That permitting the selling, dispensing or giving away of alcoholic liquor, to or for an individual being less than 21 years of age, is in violation of Neb. Rev. Stat. Sec. 53-180 and/or 237-LCC6-019.01A of the Rules and Regulations of the Nebraska Liquor Control Commission.
- 2. That the license should be suspended for a mandatory period of two (2) days and that license should be suspended for an additional twenty (20) days, with the option to pay a fine in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class D Liquor License of Henderson Fuel Stop Inc, DBA – “Fuel Mart Express”, 908 Road B, Henderson, Nebraska, should be, and the same hereby is, suspended for a period of two (2) mandatory closure days and suspended and additional twenty (20) days, with the option to pay a fine lieu thereof, such mandatory closure to be October 7th, 2019 and October 8th, 2019; and the additional twenty (20) day suspension to commence on October 9th, 2019, and to continue until the opening hour of business on the 29th day of October 2019, with the option to pay a fine in lieu thereof


IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$167.96.


