**ORDER**

Now on the 5th day of March 2019, this matter came on for consideration before the Nebraska Liquor Control Commission, the licensee having executed a voluntary appearance, waiver of public hearing, plea of guilty, and consent to judgment, in regard to the charge filed on the 15th day of February 2019.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did, extend credit in the sale of alcoholic liquor at retail, in violation of Neb. Rev. Stat. Sec. 53-183 and/or 237-LCC6-019.01M of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. That the license should be suspended for a period of five (5) days, with the option to pay a fine in lieu thereof.
3. That a condition shall be placed on the license of no violations for eighteen (18) months from the date of this Order.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class X Liquor License of Italian Vine Wine Distrib LLC, DBA – “Italian Vine Wine Distributors”, 5612 S 49 Street, Lincoln, Nebraska, should be, and the same hereby is, suspended for a period of five (5) days, such suspension to commence at the closing hour of business on the 3rd day of May 2019, and to continue until the opening hour of business on the 9th day of May 2019, with the option to pay a fine in lieu thereof. Additionally, that a condition shall be placed on the license of no violations for eighteen (18) months from the date of this Order.


IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.
