ORDER

Now on the 8th day of January 2020, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The licensee was present and represented by Attorney David Watermeier. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon opening of the hearing, the licensee entered a plea of guilty to the charge.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did, on or about February 10, 2019, sell, dispense, furnish or allow possession of alcoholic liquor to an individual who had become intoxicated by the previous consumption of alcoholic liquor, in violation of 237-LCC6-019.01N of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. That the license should be suspended for a period of forty (40) days, with the option to pay a fine in lieu thereof.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class I Liquor License of Atemajac Inc, DBA – “La Cabana”, 3223 Cornhusker Highway, Lincoln, Nebraska, should be, and the same hereby is, suspended for a period of forty (40) days, such suspension to commence at the closing hour of business on the 29th day of March 2020, and to continue until the opening hour of business on the 9th day of May 2020, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.


IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$64.22.
