**ORDER**

Now on the 9<sup>th</sup> day of October 2018, this matter came on for consideration before the Nebraska Liquor Control Commission upon a request for reconsideration having been filed by Atemajac Inc., dba "La Cabana", 3223 Cornhusker Highway, Lincoln, Nebraska, said application having been previously suspended by this Commission in Order dated August 16<sup>th</sup>, 2018.

The licensee was present and represented by Attorney Terry Poppe. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did, on or about March 11<sup>th</sup>, 2018, sell, dispense, furnish or allow possession of alcoholic liquor, to or for an individual who had become intoxicated by the previous consumption of alcoholic liquor, in violation of 237-LCC6-019.01N of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. That the license should be suspended for a period of twenty-four (24) days, with the option to pay a fine in lieu thereof.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class I Liquor License of Atemajac Inc, DBA – "La Cabana", 3223 Cornhusker Highway, Lincoln, Nebraska, should be, and the same hereby is, suspended for a period of twenty-four (24) days, such suspension to commence at the closing hour of business on the 25th day of November 2018, and to continue until the opening hour of business on the 20th day of December 2018, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$25.00.


