ORDER

Now on the 7th day of June 2016, this matter came on for consideration before the Nebraska Liquor Control Commission, the licensee having executed a voluntary appearance, waiver of public hearing, plea of guilty, and consent to judgment, in regard to the charge filed on the 9th day of May 2016.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did on or about November 4, 2015, purchase, receive, acquire, accept, or possess alcoholic liquors from persons not authorized to sell to the licensee, in violation of Neb. Rev. Stat. Sec. 53-175.
2. That the licensee did, fail to retain and preserve true books of accounts and records of all business receipts, disbursements and funds used in connection with the licensed business, in violation of 237-LCC7-002 of the Rules and Regulations of the Nebraska Liquor Control Commission.
3. That the license should be suspended for seven (7) days on charge #1 and suspended for (8) days on charge #2 for a total period of fifteen (15) days suspension, with the option to pay a fine in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of Harlan Wayne Brott, DBA – “Little Country Kitchen & Lounge”, 103 N Perkins Avenue, Madrid, Nebraska, should be, and the same hereby is, suspended for seven (7) days on charge #1 and suspended for eight (8) days on charge #2 for a total period of fifteen (15) days suspension, such suspension to commence at the closing hour of business on the 24th day of July 2016, and to continue until the opening hour of business on the 9th day of August 2016, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$0.00.


