### **RENEWALS NON-CLASS C:**

Non-Class Class C Licenses are due April 30th. Licenses are mailed daily as they renew. Please recommend to licensees to renew on-line if they have not yet renewed.

If you wish to check to see if a licensee has renewed, you may search the licensee at this link:

For best results in searching for a licensee, please enter **Retail** for category and then license number (6 digits only). Once you've found the licensee, scroll to the bottom in the history box. If you find in "Description: RENEW APP" with an effective date after February 2019, you will know that they have renewed. If no "RENEW APP" shows for 2019, they have not renewed in our system.

### **SPECIAL DESIGNATED LICENSE NEWS:**

The Nebraska Legislature has approved a bill that will affect Special Designate Licenses. We will keep you updated when these changes will take place. With the statute change, two items will be affected:

- ◆ SDL licenses will be able to be electronically delivered to the local governing body
- ◆ The Local governing body would be able to create an expedite process for licensed caterers that would normally need to have the application into their office a minimum of 21-days. If expedite process is used, the deadline will be at least 12-days prior to the event for emergency applications. This change will not affect the 10-day NLCC rule.
