

ORDINANCE NO. 514

AN ORDINANCE TO AMEND SECTION 10-117 OF THE MUNICIPAL CODE FOR THE CITY OF NEWMAN GROVE, NEBRASKA, RELATING TO HOURS OF SALE FOR ALCOHOLIC BEVERAGES:

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF NEWMAN GROVE, NEBRASKA:

Section 1. That Section 10-117 of the Municipal Code of the City of Newman Grove, Nebraska shall be amended as follows:

State Statute 10-117 ALCOHOLIC BEVERAGES; HOURS OF SALE. It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the Municipality except during the hours provided herein:

HOURS OF SALE

Alcoholic Liquors (except beer and wine)

Secular Days

Off Sale ..... 6:00 a.m. to 1:00 a.m.  
On Sale ..... 6:00 a.m. to 2:00 a.m.

Sundays

Off Sale ..... Noon to 1:00 a.m.  
On Sale ..... Noon to 2:00 a.m.

Beer and Wine

Secular Days

Off Sale ..... 6:00 a.m. to 1:00 a.m.  
On Sale ..... 6:00 a.m. to 2:00 a.m.

Sundays

Off Sale ..... Noon to 1:00 a.m.  
On Sale ..... Noon to 2:00 a.m.

Provided, that such limitations shall not apply after twelve (12:00) o'clock Noon on Sunday to a licensee which is a non-profit corporation holding a license pursuant to Section 53-124(5) © & (H) Reissue Revised Statutes of Nebraska 1943.

No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than fifteen (15) minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises. For the purpose of the Section, "on sale" shall be defined as alcoholic beverages sold by the drink for consumption on the premises of the licensed establishment; "off sale" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

Nothing in this Section shall be construed to prohibit licensed premises from being open for other business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this Section. (Ref. 53-179 RS Neb.)

Section 2. This Ordinance shall be in full force and shall take effect from and after its passage, approval, and publication according to law.
