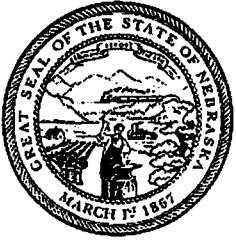

Dear Licensee/Applicant:

You are hereby notified to appear before the Nebraska Liquor Control Commission at its offices on the 5th floor of the State Office Building, located at 301 Centennial Mall South, Lincoln, Nebraska, on **Tuesday, March 5th, 2019 at 11:15 A.M.** or as soon thereafter as it may be heard for a hearing on a citation which has been issued against you to determine if your license should be suspended, cancelled or revoked. You have been charged with:

That the licensee did, purchase alcoholic liquor from Italian Vine Wine Distributors, and did accept merchandising credit thereupon for a period exceeding thirty days, in violation of Neb. Rev. Stat. Sec. 53-168 and/or 237-LCC6-019.01K and 237-LCC6-018.01A of the Rules and Regulations of the Nebraska Liquor Control Commission.

The Voluntary Appearance and Plea of Guilty form enclosed is for your signature if you desire to enter a plea of guilty to the charges filed against you and waive the hearing (this means there will be no hearing if you sign the waiver and plead). This, of course, would save you the expense of a court reporter and witness fees. However, in order to save the expense, your Plea of Guilty form should be executed and returned to this office by **January 25th, 2019**, in order for us to contact the witnesses and advise them that they do not need to appear. If you sign this form, you may present a letter or affidavit of your facts in this matter to be considered by the Commission in mitigation of the charges. Upon a plea of guilty, the investigation report will be entered on the record and if any officers or investigators are present they may be asked to provide the Commission with further information.

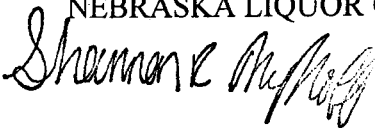
In the event you are found guilty, additional information may be supplied by law enforcement regarding the conduct of your business. If a letter is received from law enforcement, you may inspect the letter five days before the hearing and present any additional information at a separate penalty hearing. The Commission always reviews a licensee's history sheets after finding a licensee guilty and before setting a penalty. You may review your history sheets at the Commission office any time before the day of the hearing. Any comments you wish to make about the history sheets may be made in written form and will be presented to the Commission at the time they review the history sheets.

Regarding any penalty that may be sanctioned, if the Commission determines that a suspension should be imposed, there is within the Nebraska Statutes a statute which gives a retail licensee an option to elect to pay a fine (cash penalty) in lieu of suspending sales of alcoholic liquor.

I want to emphasize that you have the right to a hearing and that you should not execute the enclosed form unless you wish to waive the hearing and plead guilty. Requests for continuances will be granted *only* in extreme circumstances, and as a general policy, will not grant continuances received within five working days of the hearing date. You might wish to consult your attorney. If, however, you have a question in this matter, please feel free to contact this office.

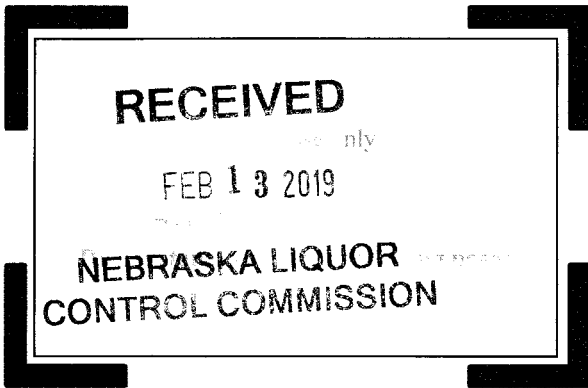

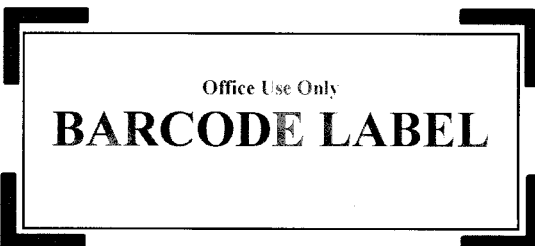
