ORDINANCE NO. 507

NEBRASKA LIQUOR
CONTROL COMMISSION

AN ORDINANCE OF THE VILLAGE OF AXTELL, NEBRASKA PERTAINING TO THE SALE OF ALCOHOLIC BEVERAGES; TO AMEND SECTION 10-117 OF THE MUNICIPAL CODE TO CHANGE THE HOURS OF SALE; TO REPEAL THE ORIGINAL SECTION; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO DECLARE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD CHAIRMAN AND TRUSTEES OF THE VILLAGE OF AXTELL, NEBRASKA:

Section 1. That Section 10-117 of the Municipal Code of the Village of Axtell, Nebraska, is hereby amended to read as follows:

10-117 ALCOHOLIC BEVERAGES; HOURS OF SALE.

It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the Municipality except during the hours provided herein:

HOURS OF SALE

Alcoholic Liquors (except beer and wine)

Secular Days

Off Sale ----- 6:00 a.m. to 1:00 a.m.

On Sale -----6:00 a.m. to 2:00 a.m.

Sundays

Off Sale -----12:00 noon to 1:00 a.m.

On Sale -----12:00 noon to 2:00 a.m.

Beer and Wine

Secular Days

Off Sale -----6:00 a.m. to 1:00 a.m.

On Sale -----6:00 a.m. to 2:00 a.m.

Sundays

Off Sale -----6:00 a.m. to 1:00 a.m.

On Sale -----6:00 a.m. to 2:00 a.m.

Provided that such limitations shall not apply after twelve o'clock (12:00) Noon on Sunday to a licensee which is a non-profit corporation holding a license pursuant to Section 53-124(5) (C) and (H) Reissue Revised Statutes of Nebraska 1943.

No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than fifteen (15) minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises.

For the purposes of this Section, "on sale" shall be defined as alcoholic beverages sold at retail by the drink for consumption on the premises of the licensed establishment, "off sale" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

Nothing in this Section shall be construed to prohibit licensed premises from being open for business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this Section.

Section 2. That the original provision of Sec. 10-117 of the Municipal Code are hereby repealed.

Section 3. That this ordinance shall be published in pamphlet form as part of the Municipal Code of the Village of Axtell, Nebraska.

Section 4. That this ordinance shall be in full force and effect from and after its passage, approval, and publication according to law.
