ORDINANCE NO. 2010-02

AN ORDINANCE to amend the Bellwood Municipal Code Section 4-106 relating to hours of sale of alcoholic liquor, including beer and wine; to repeal ordinances or parts thereof in conflict therewith; and to provide an effective date thereof.

BE IT ORDAINED BY THE CHAIRMAN AND THE VILLAGE BOARD OF BELLWOOD, BUTLER COUNTY, NEBRASKA, that pursuant to authority granted in Nebraska Legislative Bill 861, Section 4-106 of the Bellwood Municipal Code is hereby amended to read as follows:

SECTION 4-106: HOURS OF SALE

1. For the purposes of this section, (A) "on-sale" shall be defined as alcoholic beverages sold by the drink for consumption on the premises of the licensed establishment; (B) "off-sale" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

2. It shall be unlawful for any person or persons, or their agents, to sell at retail or dispense any alcoholic beverages within the Village except during the hours specifically provided herein, as follows:

Alcoholic Liquors (except beer and wine)

Monday through Saturday

Off Sale 6:00 A.M. to 1:00 A.M.  
On Sale 6:00 A.M. to 2:00 A.M.

Sunday

Off Sale 6:00 A.M. to 1:00 A.M.  
On Sale 12:00 Noon to 2:00 A.M.

Beer and Wine

Monday through Saturday

Off Sale 6:00 A.M. to 1:00 A.M.  
On Sale 6:00 A.M. to 2:00 A.M.

Sunday

Off Sale 6:00 A.M. to 1:00 A.M.  
On Sale 6:00 A.M. to 2:00 A.M.

3. Such limitations shall not apply after 12:00 noon on Sunday to a licensee which is a nonprofit corporation and the holder of a Class C license or a Class I license.

4. It shall be unlawful on property licensed to sell alcoholic liquor at retail to allow alcoholic liquor in open containers to remain or be in possession or control of any person for purposes of consumption between the hours of 2:15 a.m. and 6:00 a.m. on any day.

5. Nothing in this section shall be construed to prohibit licensed premises from being open for other business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this section.


Section 4-106 of the Bellwood Code as heretofore existing is hereby repealed.
