

**VILLAGE OF LITCHFIELD**

**ORDINANCE NO 2011-01**

AN ORDINANCE AMENDING §10-117 OF THE VILLAGE OF LITCHFIELD MUNICIPAL CODE AS ENACTED IN THE VILLAGE OF LITCHFIELD ORDINANCE NO 2011-01 REGARDING THE ON-PREMISES SALE AND DISPENSING OF ALCOHOLIC BEVERAGES UNTIL 2:00 A.M. AND CORRECTING THE HOURS OF SALE OF ALCOHOLIC LIQUORS (EXCEPT BEER AND WINE).

**BE IT ORDAINED BY THE CHAIRMAN AND THE BOARD OF TRUSTEES OF THE VILLAGE OF LITCHFIELD, SHERMAN COUNTY, NEBRASKA:**

WHEREAS, it appears desirable and for the public good and the best interest of the Village of Litchfield that an Ordinance be passed amending §10-117 of the Village of Litchfield's Municipal Code as enacted in the Village of Litchfield's Ordinance NO 2011-01 regarding the on-premises sale and dispensing of alcoholic beverages until 2:00 am and correcting the hours of sale of alcoholic liquors (except beer and wine).

Section 1 §of the Village of Litchfield's Municipal Code as enacted in the Village of Litchfield's Ordinance No 2011-01 is amended so as to provide as follows:

**SECTION 10-117 ALCOHOLIC BEVERAGES: HOURS OF SALE**

It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the Municipality except during the hours provided herein;

**HOURS OF SALE**

Alcoholic Liquors (except beer and wine)

**Secular Days**

Off Sale.....8:00 A.M. to 1:00 A.M.

On Sale.....8:00 A.M. to 2:00 A.M.

**Sundays**

Off Sale.....Noon to 1:00 A.M.

On Sale.....Noon to 2:00 A.M.

**Beer and Wine**

**Secular Days**

Off Sale.....8:00 A.M. to 1:00 A.M.

On Sale.....8:00 A.M. to 2:00 A.M.

**Sundays**

Off Sale.....8:00 A.M. to 1:00 A.M.

On Sale.....8:00 A.M. to 2:00 A.M.

No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than fifteen (15) minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises. For the purposes of this section "on sale" shall be defined as alcoholic beverages sold by the drink for consumption on the premises of the licensed establishment; "off sale" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

Nothing if the section shall be construed to prohibit licensed premises from being open for other business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this section.

SECTION 2. That all ordinances and parts of ordinances passed and approved prior to the passage and approval of this ordinance and in conflict therewith are hereby repealed.

SECTION 3. That this ordinance shall be in full force and take effect as of the 2<sup>nd</sup> day of February 2011 and after its passage, approval and publication according to law.
