ORDINANCE 2010-03

AN ORDINANCE OF THE VILLAGE OF MARQUETTE, NEBRASKALIQUOR PERTAINING TO THE SALE OF ALCOHOLIC BEVERAGES; TO AMENDOMANISSION SECTION 111.48 OF THE BASIC CODE TO CHANGE THE HOURS OF SALE; TO REPEAL THE ORIGINAL SECTION; TO PROVIDE FOR PUBLICATION IN POSTING FORM; AND TO DECLARE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRMAN AND VILLAGE BOARD OF THE VILLAGE OF MARQUETTE, NEBRASKA:

Section 1. That section 111.48 of the Basic Code of the Village of Marquette, Nebraska, is hereby amended to read as follows:

§111.48 ALCOHOLIC BEVERAGES; HOURS OF SALE.

It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the Municipality except during the hours provided herein:

Provided that such limitations shall not apply after twelve o'clock (12:00) Noon on Sunday to a licensee which is a non-profit corporation holding a license pursuant to Section 111.48 (B), (C) and (D) Reissue Revised Statutes of Nebraska 1943.

- No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than fifteen (15) minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said significant premises.

For the purposes of this Section "on sale" shall be defined as alcoholic beverages sold at retail by the drink for consumption on the premises of the licensed establishment, "off sale" shall be defined as alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

Nothing in this Section shall be construed to prohibit licensed premises from being open for business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this section.

Section 2. That the original provisions of Sec. 111.48 of the Basic Code are hereby repealed.

Section 3. That this ordinance shall be posted form as part of the Basic Code of the Village of Marquette, Nebraska.

Section 4. That this ordinance shall be in full force and effect from and after its passage, approval, and posting according to law.
