ORDINANCE NO. 2010-2107M

AN ORDINANCE OF THE CITY OF VALENTINE, NEBRASKA AMENDING CHAPTER 10, ARTICLE 1, SECTION 10-106 OF THE MUNICIPAL CODE OF THE CITY OF VALENTINE, NEBRASKA, ORDINANCE NO. 77-629M, PROVIDING FOR CHANGES TO THE HOURS OF SALE OF ALCOHOLIC BEVERAGES; PROVIDING FOR THE REPEAL OF ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; PROVIDING FOR PUBLICATION OF THIS; AND PROVIDING WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND TAKE EFFECT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VALENTINE, NEBRASKA, TO WIT:

SECTION 1: That Chapter 10, Article 1, Section 10-106 of the Valentine Municipal Code, be amended as follows:

ALCOHOLIC BEVERAGES: HOURS OF SALE

(A) For the purpose of this section, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

OFF SALE. Alcoholic beverages sold at retail in the original container for consumption off the premises of the licensed establishment.

ON SALE. Alcoholic beverages sold at retail by the drink for consumption on the premises of the licensed establishment.

(B) It shall be unlawful for any licensed person or persons or their agents to sell any alcoholic beverages within the Municipality except during the hours provided herein, provided that such limitations shall not apply after 12:00 pm noon on Sunday to a licensee which is a nonprofit corporation holding a license pursuant to Neb. RS 53-124(5)(C):

(C) No person or persons shall consume any alcoholic beverages on licensed premises for a period longer than fifteen (15) minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises.

(D) Nothing in this Section shall be construed to prohibit licensed premises from being open for other business on days and hours during which the sale or dispensing of alcoholic beverages is prohibited by this Section. (Ref. 53-179 RS Neb.)

SECTION 2: All ordinances or parts of an ordinance in conflict herewith are hereby repealed.

SECTION 3: This ordinance shall be published pursuant to law.

SECTION 4: The provisions of this ordinance are separable, and the invalidity of any phrase, clause or part of this ordinance shall not affect the validity or effectiveness of the remainder of the ordinance.

SECTION 5: This ordinance shall be in full force and take effect from and after its approval, passage, and publication according to law.
