Now on the 11<sup>th</sup> day of July 2023, this matter came on for consideration before the Nebraska Liquor Control Commission, to show cause why the license should not be suspended, cancelled or revoked for:

1. Filing a false renewal in violation of Neb. Rev. Stat. Sec. 53-131.01, i.e., James T Rogers, 50 % owner, president, and manager, passed away in December of 2020.
2. Failure to file corporate changes as required by 237-LCC3-002.04 of the Rules and Regulations of the Nebraska Liquor Control Commission.
3. Failure to file a new manager's application with the Commission within sixty (60) days, in violation of 237-LCC2-009.01 of the Rules and Regulations of the Nebraska Liquor Control Commission.

The licensee was present. The Commission was represented by Ken Yoho, Assistant Attorney General.

FINDINGS OF FACT:

1. That the licensee filed false renewals in violation of Neb. Rev. Stat. 53-131.01.
2. That the license failed to file corporate changes with the Commission.
3. That the licensee failed to file a manager's application with the Commission within sixty (60) days.

CONCLUSION OF LAW:

1. That filing false renewals is in violation of Neb. Rev. Stat. 53-131.01.
2. That failing to file corporate changes with the Commission is in violation of 237-LCC3-002.04 of the Rules and Regulations of the Nebraska Liquor Control Commission.
3. That failing to file a manager's application with the Commission within sixty (60) days is in violation of 237-LCC2-009.01 of the Rules and Regulations of the Nebraska Liquor Control Commission.
4. That the license shall be cancelled.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of Celebration of Life Enterprise dba "Pan Asian Terrace", 1201 S 157<sup>th</sup> Street, Suite A-1, Omaha NE, should be, and the same hereby is, cancelled, effective at the closing hour of business on the 15<sup>th</sup> day of August 2023.

IT IS FURTHER ORDERED that the State shall pay costs of this action, assessed in the amount of \$35.00.


