ORDER

Now on the 2nd day of August 2022, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The licensee was represented by Attorney Michael Kelley via Zoom. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon opening of the hearing, the licensee entered a guilty plea to the charges.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did purchase, receive, acquire, accept or possess alcoholic liquors from persons not authorized to sell to the licensee, in violation of Neb. Rev. Stat. Sec. 53-175.
2. That the license should be suspended for a period of fifteen (15) days, with the option to pay a fine in lieu thereof.
3. That the licensee shall pay excise tax in the amount of \$2.81 within thirty (30) days from the date of this order.
4. That the alcohol seized during this investigation shall be destroyed by the Nebraska State Patrol in accordance with Neb. Rev. Stat. 53-1,113.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of Rumor Has It LLC, DBA – “Philly Sports Bar and Grill”, 8116 S 84th Street, LaVista, Nebraska, should be, and the same hereby is, suspended for a period of fifteen (15) days, such suspension to commence at the closing hour of business on the 25th day of September 2022, and to continue until the opening hour of business on the 11th day of October 2022, with the option to pay a fine in lieu thereof. Additionally, that the licensee shall pay excise tax in the amount of \$2.81 within thirty (30) days from the date of this Order. Furthermore, that the alcohol seized during this investigation shall be destroyed by the Nebraska State Patrol in accordance with Neb. Rev. Stat. 53-1,113.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$35.00.


