ORDER

Now on the 3<sup>rd</sup> day of May 2022, this matter came on for hearing before the Nebraska Liquor Control Commission, an order to show cause why the license should not be suspended, cancelled or revoked for:

1. Failure to file corporate changes as required by 237-LCC3-002.04 of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. Failure to file a new manager's application with the Commission within sixty (60) days, in violation of 237-LCC2-009.01 of the Rules and Regulations of the Nebraska Liquor Control Commission.

The licensee was present. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the Licensee did fail to file corporate changes as required by 237-LCC3-002.04 of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. That the Licensee did fail to file a new manager's application with the Commission within sixty (60) days, in violation of 237-LCC2-009.01 of the Rules and Regulations of the Nebraska Liquor Control Commission.
3. That the license should be suspended for a period of five (5) days, with the option to pay a fine in lieu thereof.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of Pivo's Tavern LLC, DBA – "Pivo's Tavern", 182 N 2nd Street, Dwight, Nebraska, should be, and the same hereby is, suspended for a period of five (5) days, such suspension to commence at the closing hour of business on the 24th day of July 2022, and to continue until the opening hour of business on the 30th day of July 2022, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.


IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$35.00.
