ORDER

Now on the 11th day of September 2018, this matter came on for consideration before the Nebraska Liquor Control Commission, the licensee having executed a voluntary appearance, waiver of public hearing, plea of guilty, and consent to judgment, in regard to the charge filed on the 21st day of August 2018.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

- 1. That the licensee did, purchase alcoholic liquor from Republic National Distributing Company and did accept merchandising credit thereupon for a period exceeding thirty days, in violation of Neb. Rev. Stat. Sec. 53-168 and/or 237-LCC6-019.01K and 237-LCC6-018.01A of the Rules and Regulations of the Nebraska Liquor Control Commission.
- 2. That the license should be suspended for a period of Three (3) days, with the option to pay a fine in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of Playmakers Entertainment Group LLC, DBA – “Playmakers Pizzeria and Sports Grill”, 12744 Westport Parkway, Suite 1A, LaVista, Nebraska, should be, and the same hereby is, suspended for a period of Three (3) days, such suspension to commence at the closing hour of business on the 28th day of October 2018, and to continue until the opening hour of business on the 1st day of November 2018, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$0.00.
