**ORDER**

Now on the 7th day of August 2019, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The licensee was present and represented by Attorney Michael Kelley. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon opening of the hearing, the licensee entered a plea of guilty to the charge.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did, on or about April 6<sup>th</sup>, 2019 permit open containers of alcoholic liquor to remain or to be in possession or control of persons for the purposes of consumption after 2:15a.m., in violation of Neb. Rev. Stat. Sec. 53-179(3) and/or 237-LCC6-019.01D of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. That the license should be suspended for a period of five (5) days, with the option to pay a fine in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of Rhythmz LLC, DBA – “Rhythmz Lounge and Bistro”, 10841 Q Street, Omaha, Nebraska, should be, and the same hereby is, suspended for a period of five (5) days, such suspension to commence at the closing hour of business on the 6th day of October 2019, and to continue until the opening hour of business on the 12th day of October 2019, with the option to pay a fine in lieu thereof

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.


IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$35.00.
