**ORDER**

Now on the 10th day of July 2018, this matter came on for consideration before the Nebraska Liquor Control Commission, the licensee having executed a voluntary appearance, waiver of public hearing, plea of guilty, and consent to judgment, in regard to the charge filed on the 11th day of June 2018.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

- 1. That the licensee did, on or about March 17, 2018, permit the selling, dispensing, or giving away of alcoholic liquor, to or for an individual being less than 21 years of age, in violation of Neb. Rev. Stat. Sec. 53-180 and/or 237-LCC6-019.01A of the Rules and Regulations of the Nebraska Liquor Control Commission.
- 2. That the license shall be suspended for a mandatory period of two (2) days and that the license should be suspended for an additional forty-two (42) days, with the option to pay a fine in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class IDK Liquor License of Schmick's Market Inc, DBA – "Schmick's Market", 1110 S B Street, Broken Bow, Nebraska, should be, and the same hereby is, suspended for a period of two (2) mandatory closure days and suspended an additional forty-two (42) days, with the option to pay a fine in lieu thereof, such mandatory closure to be August 27<sup>th</sup>, 2018 and August 28<sup>th</sup>, 2018, and the additional forty-two (42) day suspension to commence on August 29<sup>th</sup>, 2018, and to continue until the opening hour of business on the 10th day of October 2018, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$0.00.
