ORDER

Now on the 1st day of September 2020, this matter came on for consideration before the Nebraska Liquor Control Commission, the licensee having executed a voluntary appearance, waiver of public hearing, plea of guilty, and consent to judgment, in regard to the charge filed on the 7th day of July 2020.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did purchase, receive, acquire, accept or possess alcoholic liquors from persons not authorized to sell to the licensee, in violation of Neb. Rev. Stat. Sec. 53-175.
2. That the licensee did, on or about July 7, 2020, have in its possession, for sale at retail, refilled bottles of alcoholic liquor, which said bottles were not the original bottles for said alcoholic liquor, in violation of Neb. Rev. Stat. Sec. 53-184 and/or 237-LCC6-019.01J of the Rules and Regulations of the Nebraska Liquor Control Commission.
3. That the license should be suspended for ten (10) days on charge #1 and suspended for ten (10) days on charge #2 for a total period of twenty (20) days, with the option to pay a fine in lieu thereof.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class CK Liquor License of Ryan Peterson, DBA – “West Side Bar”, 310 Main Street, Stromsburg, Nebraska, should be, and the same hereby is, suspended for ten (10) days on charge #1 and suspended for ten (10) days on charge # 2 for a total period of twenty (20) days, such suspension to commence at the closing hour of business on the 1st day of November 2020, and to continue until the opening hour of business on the 22nd day of November 2020, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the Licensee shall pay costs of this action, assessed in the amount of \$0.00.


