Now on the 6<sup>th</sup> day of July, 2016, this matter came on for consideration before the Nebraska Liquor Control Commission, whether to set a show cause hearing for licensee to file a new application due to denial of the manager application on licensee Jeffrey L. Hubbard in Commission Order dated June 23, 2016, and continuing Lincoln ordinance violations.

FINDINGS OF FACT:

- 1. The location has been without an approved manager for over sixty (60) days.
- 2. The application to be manager of principal owner Jeffrey L. Hubbard was denied by the Commission in order dated June 23, 2016. (attached)


CONCLUSION:

- 1. The lack of a manager raises questions over the ability to comply with all aspects of the Nebraska Liquor Control Act and are a material change to the operation of the license.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C-84138 Liquor Licensee, GJJRB LLC, dba "The Spigot Lounge", 1624 O Street, Lincoln, Nebraska shall file a new application with the Commission within two (2) weeks from the date of this Order or license shall be cancelled effective at the closing hour of business on the 31<sup>st</sup> day of July, 2016.

Now on the 7<sup>th</sup> day of June, 2016, this matter came on for hearing before the Nebraska Liquor Control Commission, upon an order to show cause why the Manager's application of Jeffrey L. Hubbard should not be denied, i.e., Investigator has concerns whether applicant can conform to all provisions and requirements of the rules and regulations adopted pursuant to the Nebraska Liquor Control Act, as applicant shows consistent history of failing to abide by rules, regulations, ordinances, and laws.

In accordance with the Commission's policies, a proper notice of this hearing was sent by regular U.S. mail.

The applicant was not present nor represented. The City of Lincoln was represented by Investigator Schafer from the Lincoln Police Department. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Evidence was introduced, oral arguments were heard and the matter submitted to the Commission.

FINDINGS OF FACT:

1. That the Commission has found that the manager applicant Jeffrey L. Hubbard is not of good character and reputation in the community.
2. In making its determination, the Commission considered:
  - (a) The recommendation of the local governing body

CONCLUSION

1. That for all the reasons set out in the findings of fact, the manager's application of Jeffrey L. Hubbard should be denied.




