ORDER

Now on the 23rd day of September 2015, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The licensee was present. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon opening of the hearing the licensee plead guilty to the charge.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did, on or about April 9, 2015, permit the selling, dispensing, or giving away and/or possession of alcoholic liquor, to or for an individual being less than 21 years of age, in violation of Neb. Rev. Stat. Sec. 53-180 and/or 237-LCC6-019.01A of the Rules and Regulations of the Nebraska Liquor Control Commission
2. That the license should be suspended for a period of ten (10) days, with the option to pay a fine in lieu thereof.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of LD1 Ne Omaha SBS LLC, DBA – “Staybridge Suites Omaha”, 7825 Davenport Street, Omaha, Nebraska, should be, and the same hereby is, suspended for a period of ten (10) days, such suspension to commence at the closing hour of business on the 15th day of November, 2015, and to continue until the opening hour of business on the 26th day of November, 2015, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the licensee shall pay costs of this action, assessed in the amount of \$161.13.
