ORDER

Now on the 20th day of August 2015, this matter came on for consideration before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The licensee was present. The State was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Based upon the testimony of the witness and the evidence in this case the Commission finds the following:

FINDING OF FACT:

1. That during various times between October 2014 and March 5, 2015, the licensee did purchase, receive, acquire, accept or possess alcoholic liquors from persons not authorized to sell to the licensee.

CONCLUSION OF LAW:

1. That purchasing, receiving, acquiring, accepting or possessing alcoholic liquors from persons not authorized to sell to the licensee is in direct violation of Neb. Rev. Stat. Sec. 53-175 of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. That the license should be suspended for a period of five (5) days, with the option to pay a fine in lieu thereof.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C Liquor License of Caribbean Delights Inc., dba "Caribbean Delights", 2304 N 72 Street, Omaha Nebraska, should be, and the same hereby is, suspended for a period of five (5) days, such suspension to commence at the closing hour of business on the 11th day of October 2015, and to continue until the opening hour of business on the 17th day of October 2015, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.

IT IS FURTHER ORDERED that the licensee shall pay costs of this action, assessed in the amount of \$25.00.
