ORDER

Now on the 28th day of July 2015, this matter came on for hearing before the Hearing Officer appointed by the Nebraska Liquor Control Commission pursuant to 237-LCC1-002.14 of the Rules and Regulations of the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended cancelled or revoked as more fully set out herein.

In accordance with the Commission's policies, a proper notice of this hearing was sent by U.S. Regular Mail, return receipt requested.

The licensee was not present nor represented. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon consideration of all the evidence in this case, the Nebraska Liquor Control Commission finds:

1. That the licensee did file a renewal for license after the date prescribed by law, in violation of Neb. Rev. Stat. Sec. 53-135 and/or 237-LCC1-008 of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. That the license should be suspended for a period of three (3) days, with the option to pay a fine in lieu thereof.


IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class I Liquor License of San Pedro Inc., dba "San Pedro", 1002 S Jeffers Street, North Platte, Nebraska, should be, and the same hereby is, suspended for a period of three (3) days, such suspension to commence at the closing hour of business on the 11th day of October 2015, and to continue until the opening hour of business on the 15th day of October 2015, with the option to pay a fine in lieu thereof.

IT IS FURTHER ORDERED that the notice of suspension shall be posted upon the premises, said notice to remain posted throughout the term of said suspension.


IT IS FURTHER ORDERD that the Licensee shall pay hearing costs assessed in the amount of \$25.00.
