**ORDER  
NUNC PRO TUNC**

Now on the 20<sup>th</sup> day of August, 2015, this matter came on for hearing before the Nebraska Liquor Control Commission, notice having been served upon the licensee to appear and respond to an administrative citation alleging that the license should be suspended, cancelled or revoked as more fully set out herein.

The licensee was present. The Commission was represented by Milissa Johnson-Wiles, Assistant Attorney General.

Upon opening of the hearing, the licensee entered a plea of guilty to the charge.

Upon consideration of all the evidence in this matter, the Nebraska Liquor Control Commission finds:


1. That the licensee did, on or about March 19, 2015, have in its possession, for sale at retail, refilled bottles of alcoholic liquor, which said bottles were not the original bottles for said alcoholic liquor, in violation of Neb. Rev. Stat. Sec. 53-184 and/or 237-LCC6-019.01J of the Rules and Regulations of the Nebraska Liquor Control Commission.
2. That the licensee did, various times between February 1, 2014, and February 1, 2015, purchase, receive, acquire, accept or possess alcoholic liquors from persons not authorized to sell to the licensee, in violation of Neb. Rev. Stat. Sec. 53-175.
3. That the licensee did, at various times between February 1, 2014, and February 1, 2015, possess alcoholic liquors to which no Nebraska State excise tax had been paid in violation of Neb. Rev. Stat. Sec. 53-160.
4. That the license should be suspended for a period of twenty (20) days.
5. That the licensee shall pay penalty and interest in the amount of \$4,160.43 within thirty (30) days from the date of this Order.
6. That there be no violations for one (1) year from the date of this Order.

IT IS THEREFORE CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Retail Class C-97046 Liquor License of Todorovich Management Company, dba "Starsky's", located at 7812 F Street, Omaha, Nebraska, should be, and the same hereby is suspended for a period of twenty (20) days, such suspension to commence at the closing hour of business of the 4<sup>th</sup> day of October, 2015, and to continue until the opening hour of business on the 25<sup>th</sup> day of October, 2015. Additionally, that the licensee shall pay penalty and interest in the amount of \$4,160.43 within thirty (30) days from the date of this Order. Furthermore, that there be no violations for one (1) year from the date of this Order.

IT IS FURTHER ORDERED that the licensee shall pay costs of this action, assessed in the amount of \$25.00.


